Counting up; enumeration and measure; incommensurability; little and big pieces; the mystery of composition. An arithmetic world—the Fundamental Theorem of the calculus, the “right” pieces, the local and the global, history and path invariance. Adding up discrete pieces. Marginal and sticky resistance; stickiness in social science (Marshall, Keynes, and Schumpeter). A bestiary of models—deterministic and stochastic, collective mechanisms and phenomenological models; and a dispersion of interpretations. Is stickiness natural?	
Chapter 5: Economy, Perversion, and Fetishes	61
Incommensurability and individuation. Economy, exchange, property, and gift; kinship and particle physics; economy’s transformation of feudal orders; icons and protections in economy. Perversion, multiplicity, and incommensurability; a geographic analogy; mixture, impropri-	

ety, goodness, value, and authority in perversion. Fetishes: their production (alienation, composition, destabilization, and stigmatization), and the appearance of anima (analysis, emergence, and discontinuity). Anxiety and revelation.
